

## Business License Fee Schedule

### **Section 5.08.010 Auto wrecking.**

The license fee for the purchase and sale of damaged motor vehicles or parts is one **hundred dollars per year.**

### **Section 5.08.020 Barbershop.**

The license fee for a barbershop **is thirty dollars per year for one chair, plus ten dollars per year for each additional chair.**

### **Section 5.08.030 Baths, public.**

The license for public baths of any type, including steam, hamman, Turkish, mineral, mud, vapor, medicinal or otherwise, is **sixty dollars per year.**

### **Section 5.08.040 Beauty shop.**

The license fee for a beauty shop is **thirty dollars per year for one operator plus ten dollars per year** for each additional operator. This section includes all businesses performing services of women's hair dressing and/or facial treatments wherever the same shall be performed.

### **Section 5.08.050 Bureaus, travel--Ticket agencies.**

The license fee for travel bureaus, when operated independently of any common carrier, is **thirty dollars per year.**

### **Section 5.08.060 Cleaners, laundries.**

For soliciting, receiving or delivering clothing or textiles of any form or nature, in any manner, for dry cleaning or laundry services or other cleaning services, when such dry cleaning, laundry or other cleaning services are performed outside of the city, the license fee is **sixty dollars per year for each vehicle** engaged or operated in such soliciting, receiving or delivering.

### **Section 5.08.070 Confectionery wagons.**

A. For the sale or offering for sale of ice cream, soft drinks, candies, prepared foodstuffs or other foods for immediate consumption from any wagon, push cart or other vehicle by any licensee not having an established retail place of business with the city, the license fee is **twenty-five dollars per year for each vehicle.**

B. When any such vehicle is operated by an established licensed retail place of business in the city, the license fee is **twenty dollars per year for each vehicle.**

### **Section 5.08.080 Contractors--Builders.**

This section refers to "contractor" as defined in Division 3, Chapter 9, Article 2, Section 7026 of the Business and Professions Code of the State of California. Contractors who undertake, or offer to undertake, the performance of any work of improvement, maintenance, alteration or repair in or upon real property, the annual license fee is as follows:

### **Section 5.08.090 Dances, public.**

The license fee for operating a public dance hall **is two hundred dollars per year**; for operating or conducting a **single public dance, fifteen dollars each**.

### **Section 5.08.100 Gymnasium.**

A. Public. The license fee for operating any public gymnasium, physical or health conditioning or physical training business is **one hundred dollars per year**.

B. Private. The license fee for operating any private gymnasium, physical or health conditioning or physical training business, to which individual membership is held or available is **one hundred dollars per year**.

### **Section 5.08.110 Hotels, motels, lodging house, etc.**

For operating any hotel, motel or similar accommodation, the license fee is **four dollars per year for each such rental unit rented or offered for rent**.

### **Section 5.08.120 Importing of merchandise for wholesale.**

A. For the importing into the city, for any delivery therein, of any goods, wares or merchandise, when such importing and delivery is by means of any vehicle operated upon the public streets or highways, the license fees for such importing and delivery shall be based upon the average number of importings and deliveries per week and shall be in accord with the following schedule:

B. The license fees in this section apply to each and every vehicle used and/or employed in the importing of merchandise under this section provided, however, in no case shall these fees exceed two hundred dollars per year.

C. "Importing of merchandise," or any variation, as used in this section, refers to importing of merchandise at wholesale only, and for the purpose of resale. The provisions of this section shall not apply to any importing of goods, wares or merchandise where the sale and/or delivery of any goods, wares or merchandise is at retail to the ultimate consumer and/or user of such goods, wares or merchandise.

D. This section shall not apply to vehicles owned and/or operated by an established licensed place of business in the city and used exclusively for such licensed business.

### **Section 5.08.130 Importing of merchandise for retail sale.**

A. Whenever any business consists of the sale and delivery, at retail, of goods, wares or merchandise from house to house, or place to place, when such business does not maintain and operate an established retail sales store, market, or other fixed business in the city for retail sales to the general public, such business shall pay a license fee of **fifty dollars per year for each and every vehicle used in the conduct of business**.

B. "Vehicle," as used in this section, includes all automobiles, push carts, vans, trailers, or other means of transportation of persons or property on the public streets.

C. "Sale at retail" as used in this section refers to all sales where the delivery of goods, wares or merchandise is to the ultimate consumer and/or user.

D. The provisions of this section refer only to regularly established and regularly operated retail sales routes, and shall not apply to any transient, sporadic or irregular sales business which shall be classified as itinerant sales under the provisions of Section 5.08.140.

**Section 5.08.140 Itinerant vendor, peddler, salesman, solicitor, etc.**

A. For the sale or solicitation for sale of any goods, wares or merchandise to the ultimate consumer when the seller has no established place of business in the city, the license fee is **fifteen dollars per day per individual person or fifty dollars per quarter.**

B. Itinerant Christmas tree vendors shall pay a license fee of **twenty-five dollars per quarter** except for the following:

1. Sale of trees as a part of, and on the premises of, an established place of business shall include Christmas tree sales as part of the gross receipts of such business;
2. Sale of trees solely for the benefit of a charitable or nonprofit organization.

**Section 5.08.150 Masseur.**

The license fee for masseurs is **forty dollars per year** for each masseur and masseuse.

**Section 5.08.160 Palmist, fortune-teller, clairvoyant, etc.**

For practicing or engaging in the business of palmist, fortune-teller, clairvoyant, phrenologist, astrologer, necromancer, or any kindred business, the license fee is **one hundred dollars per year** or any fraction thereof without proration.

**Section 5.08.170 Photographer, itinerant.**

For every itinerant photographer or itinerant vendor or solicitor of photographic services the license fee **is fifteen dollars per day or seventy-five dollars per quarter.**

**Section 5.08.180 Professions and specified personal services.**

A. For the rendering and performing of business services in the classifications specified in this section, a license fee is due and payable annually as follows:

### **Section 5.08.190 Private detective, private patrol, watchman.**

For the business of private detective, private watchman and/or merchant patrol, the license fee is **thirty dollars per year for each individual person** employed or engaged therein.

### **Section 5.08.200 Shoe shining.**

For operating any shoe shine stand or parlor or conducting the business of boot-blackening or shoe shining, the license fee is **five dollars per year** without proration for each individual person so employed; provided, however, that payment of such fee shall be waived for any operator under the age of sixteen years.

### **Section 5.08.210 Shows, theaters, carnivals, exhibitions.**

A. For engaging in the business of operating any theater, playhouse or motion picture house at an established place of business, wholly within a structure designed and constructed for theater or auditorium purposes, the license fee shall be one hundred dollars per year.

B. For operating any carnival, traveling show, circus, collection of shows and/or attractions, exhibitions, rides, concessions, animal or mechanical, games of skill or chance, wherever conducted, the license fee is **seventy-five dollars per day, plus ten dollars per day for each concession booth, stand, exhibition, show, sideshow amusement, ride, game, gallery, attraction or other unit.**

C. Whenever any exhibition consists solely of the exhibition of any animal or article of public interest contained in, or upon, a single vehicle not operated in connection with any carnival, circus, or traveling show, the license fee is **ten dollars per day for each exhibit in, or upon, such vehicle.**

### **Section 5.08.220 Solicitor, salesman, service repairman or canvasser.**

A. A solicitor, salesman, service repairman or canvasser, for the purpose of this section, refers to any person who goes from house to house or place to place, or at any place, soliciting or taking orders for or offering to sell any goods, wares or merchandise for future delivery to the ultimate consumer or user; or soliciting or taking orders for any services or repairing to be performed in the future or doing or performing any services or repairs. The provisions of this section shall not apply to any solicitor, salesman, service repairman or canvasser employed by any business maintaining and operating an established place of business in the city.

B. Every solicitor, salesman, service repairman or canvasser shall pay a license fee of **forty dollars per year.**

**Section 5.08.230 Tattoo artists.**

The license fee for tattoo artists is **five hundred dollars per year**. In addition, the operator shall file with the city clerk a certificate of liability insurance in the amount of one million dollars naming the city as an additionally named insured.

**Section 5.08.240 Trucking, hauling.**

A. For the business of owning and operating any vehicle and/or vehicles for transportation of property for hire, irrespective of point of origin or destination of haul, where such business has an established place of business within the city, the annual license fee **is thirty dollars for the first vehicle plus ten dollars for each additional vehicle.**

B. When the business specified in this section has no established place of business, the annual fee for operation of **each vehicle operated is thirty dollars.**

**Section 5.08.250 Wrestling--Boxing.**

A. For operating or maintaining any wrestling or boxing arena for professional wrestling or boxing contests or exhibitions at an established place of business, the license fee is **one hundred twenty dollars per year.**

B. For holding professional wrestling or boxing contests or exhibitions not conducted or held at an established place of business, the license fee is **twenty-five dollars per day.**

**Section 5.12.020 Sales and services.**

A. For the maintaining, operating or carrying on of any business at an established place of business or the performance or rendering of any services within the city when such business, or the rendering of services, is not elsewhere in Chapters 5.04 through 5.12, or provided for in any other ordinance.

B. "Monthly receipts" refers to the average monthly gross receipts for the quarter immediately preceding the issuance and/or renewal of any business license. Upon commencement of a new business not in existence during such preceding quarter the minimum license fee shall be paid. Sales tax collected shall not be included in gross receipts.

C. The annual license fee shall be based upon the monthly gross receipts and in accord with the following schedule:

D. In the event any business, under this section, consists entirely of sales at wholesale for purposes of resale to ultimate consumers, the license fee for such completely wholesale business shall be one-half of the fee provided in subsection C of this section, but in no event less than twenty dollars per year. In the event any licensee operates both a retail and wholesale business at the same premises, the licensee may, at his option,

segregate the wholesale from the retail business and obtain a license for each type of business. Upon failure of the licensee to so segregate, the business shall be licensed in accord with the full schedule of fees set forth in subsection C of this section.

E. In the event any business combines both sales of goods or personal property and the rendering of services, the term "monthly receipts" shall include receipts for both sales and services, whether they shall be charged for separately or as a unit price.

F. No license is required of any person employed solely for wages by any person, firm or corporation in the furtherance of a business regularly licensed by the city.

G. This section shall include, but not be limited to, the following businesses, or any combination thereof:

- Auction house;
- Automotive sales and service;
- Airplane renting, sales or service;
- Blacksmith;
- Garage;
- Retail and/or wholesale merchant;
- Repairman;
- Mechanic;
- Painter;
- Machine shop;
- Welder;
- Electrician;
- Carpenter;
- Foundry;
- Manufacturer;
- Ice plant;
- Service station;
- Restaurant and/or dining room, coffee shop, lunch room, stand or lunch counter;
- Pharmacy;
- Plumber;
- Printing and publishing;
- Soda fountain;
- Bar and/or cocktail lounge;
- Cleaning and/or dyeing;
- Laundry;
- Photographer and/or photographic studio;
- Television cable relay systems;
- Pay or subscription television;
- Warehouse;
- Stockyard;
- Shoe repairing;
- The rendering of any service whatsoever.

The rendering of any service or carrying on of any business not provided elsewhere in Chapters 5.04 through 5.12, or any other ordinance.
