#### **ELECTION INFORMATION:**

- A Resolution to Request a Measure to be placed on the November 7, 2017 ballot was brought to the City Council for consideration at the August 10, 2017 City Council Meeting and was approved unanimously. According to the "Measure J ballot question; Measure J is a Transactions and Use Tax, a tax that will provide long-term sustainability, adequate resources for emergency response, and more equitably spread the cost of Barstow Fire Protection District's services across the population it serves, including 60,000,000 annual non-resident travelers who consume taxable goods and services in Barstow; shall an ordinance be adopted to increase the sales tax by one-half of one percent, providing \$3.8 million dollars annually, expiring upon the transfer of the Barstow Fire Protection District to an agency outside the City.
- An Impartial Analysis of the Measure, Arguments for and against Measure J along with the Rebuttals to those arguments have been submitted and were available for public review for 10 days. Anyone wishing to review said documents may do so during regular business hours.
- Training for personnel to cover the duties of the early voting precinct is scheduled for October 3, 2017.

- The City Clerk's Office will be a drop off location for mail ballot voters and will be an early voting facility starting October 9, 2017, for the Special Election.
- City Clerk Cousino has again partnered with the Registrar of Voters to provide the City Council Chambers as a Poll Worker Training Center for the November 7th Special Municipal Election so that our local area poll workers don't have to travel to Victorville or San Bernardino to obtain their mandatory training. Interested individuals who want to help at the polls for the November 7th Special Municipal Election can register by calling San Bernardino Registrar of Voters Office at (909) 387-8300. Hello, this is Margaret Carter, Economic Development Administrator for the City of Barstow. I would like to take a moment to share with you several important projects that have come to fruition in the Community Development division over this past quarter.

Economic Development & Planning Office

Successor Agency for the City of Barstow:

The Successor Agency for the City of Barstow approved the sale of APN: 0427-062-42-0-000, situated in the Barstow Business Park on West Main Street to Nathan Ellis. The sale of the parcel keeps with the Agency's Long Range Property Management Plan as approved by the Department of Finance for the State of California.

Exclusive Negotiating Agreement (ENA) with Eagle Barstow 55 LLC – Sr. Housing Project

Eagle Barstow 55 LLC requested a six (6) month extension on the ENA from the City Council at the request of Supervisor Ramos. Due to administrative changes at the Department of Housing & Urban Development (HUD), additional time is needed to develop a pro forma on the residential component and HUD voucher conversion requirements and other program changes that could affect the project. The City Council approved the extension of the ENA for Eagle Barstow 55 LLC.

Request for Statement of Qualifications – Professional Marketing / Real Estate Services

A Request for Statement of Qualifications for Professional Marketing and Real Estate Services for City Owned Property was sent to local real estate offices and the High Desert Association of REALTORS and posted on the City's webpage (www.barstowca.org) on August 23, 2017. The selected firm will be responsible for the development and implementation of a marketing strategy that will lead to the successful disposition of various city owned properties. The firm's primary responsibility is to market and sell property held by the former Barstow Redevelopment Agency.

## Fire Department

BFPD Events July 2017-September 2017

- From July 01 2017 through September 25 2017 the Barstow Fire Protection District responded to 1,602 emergency incident.
- Barstow Firefighters Completed 256 man-hours of wildland refresher and update training this quarter.
- Barstow Firefighters have had several significant incidents during this quarter
- o 3- Full arrest saves CPR and advance life support intervention produced positive outcomes of patients that were found not breathing with no heartbeat..
- o 1.5 Acre brush fire in the river bottom behind the wastewater treatment plant. One victim was rescued from the middle of the burn area. This resulted in one firefighter injury for smoke inhalation and heat exhaustion- he was transported to the hospital for treatment. Additionally, two firefighters were treated for minor heat exhaustion and dehydration during the fire.
- o Fatality house fire on Mt View- one victim was pulled from the fire by firefighters, Advance Life Support intervention was ad mistered unfortunately, the victim was pronounced dead at the hospital.
- o Barstow Firefighters assisted in the firefighting efforts of several large wildland fires in California totaling 1,632 man-hours of service to these communities.

- Barstow Firefighters conducted several public education events in the community

- Registration just closed for the Indoor Kiddie Soccer for ages 2 to 3 years old and ended up with over 95 kids enrolled. Games will start on Sept 14th.
- The Community Center hosts the Blood Bank every second Tuesday of each month from 1-8pm. So please come by and help our community by donating blood.
- The County of San Bernardino has returned to Barstow with their Free Legal Aid program. They use the portable classroom located at the Cora Harper Fitness Center from 12 2 pm on the 4th Tuesday of each month.
- The Pool opened on Memorial Day with a great turnout from the community. Lap swimming was enjoyed by many of our older community members as a way of relaxation and for fitness. We closed out our season on Labor Day.
- Zumba & Volleyball was added to our list of programs and classes continue to grow each month.
- The Parks joined up with the Kiwanis Club of Barstow to put on a "Family Fun Day "on July 22nd which started out with a live free concert. The Kiwanis provided a Bounce House and Laser Tag, while we opened the pool for free swim. The Fire and Police Explorers pitched in and provided booths teaching safety awareness. We ended the night with the help of the Barstow Youth Advisory Council putting on a Movie in the Park! Moana was a perfect movie to end a perfect night. The event supplied a day of fun for over 2,000 people.
- Our Parks Maintenance Department continue on a daily basis to work vigorously to ensure that all of our parks and ballfields are maintained at the highest standards possible for our community. They have just completed painting the entire exterior of both snack bars.
- At the Sportspark, we have many ongoing things being held there like Youth recreation soccer, adult soccer, Coed and Men's Softball. The Sportspark hosted the District 49 LL Softball Tournament along with the Major and Senior League Tournaments.
- The Barstow High School and Stem School has started their 2017/18 Cross Country Season up at the Sportspark.
- The 4th of July Celebration at the Sportspark with our largest ever participation of the 5K Freedom Run with over 135 people consisting of all ages.
- Our Parks and Recreation Division assist with many community events throughout the year and we enjoy interacting with the community during these times. We look forward to helping with more community events in the future.

The following is a quarterly report from the Barstow Police Department.

#### **STATISTICS**

During this reporting period, the Barstow Police Department responded to and handled 8,797 calls for service and arrested 647 people.

## **GRANT**

The Barstow Police Department applied for and obtained a BSCC grant which provides funding to support a part-time Gang & Violence Team. The team was developed to reduce violent crime within the city and to reduce crimes associated with gangs. During this reporting period, the team made 27 arrests, authored three (3) search warrants, and recovered two (2) firearms. The team also seized 3,432 marijuana plants that were being illegal cultivated in the city.

## COMMUNITY ISSUE ENFORCEMENT EFFORT

The Barstow Police Department identified the need to address traffic law violators in areas around school zones during school hours. Primarily speeding and parking violations. As a result, the Barstow Police Department has been conducting additional speed enforcement details and directed patrols at various schools within the city. In dealing with parking issues around school zones, officers have been educating drivers on parking laws, and after this, began parking enforcement details in those areas.

In an effort to reduce overall crime in the city, the Barstow Police Department conducted a probation and parole compliance operation. As a result of the operation, the Barstow Police Department searched 54 probationer and parolees homes and arrested 26 subjects.

## ALCOHOL BEVERAGE CONTROL ENFORCEMENT

The Barstow Police Department has coordinated and worked with staff from the California Alcohol & Beverage Control to develop an effective, comprehensive and strategic approach to eliminating the crime and public nuisance problems associated with problem alcoholic beverage

outlets. Based on this, the Barstow Police Department conducted two (2) Shoulder Tap Operations at thirteen (13) businesses in the city. As a result of the operations, three (3) citations were issued to subjects who purchased alcoholic beverages for underage decoys.

The Barstow Police Department also conducted Alcohol Beverage Control Impact Inspections at twenty-two (22) alcoholic beverage outlets to determine if the businesses were in compliance with ABC standards. As a result of the inspections, all businesses were in compliance.
