PUBLIC NOTICE IS HEREBY GIVEN that the City of Barstow as AGENCY, invites sealed bids for the above stated project and will receive such bids in the office of the City Clerk, **220** E. **Mountain View Street, Suite A** up to the hour of 2:00 p.m., on the 14th day of October, 2020. The bids will be publicly opened and read at 2:00 p.m. on the 14th day of October, 2020, in the office of the City Clerk of the City of Barstow, 220 E. Mountain View St., Suite A, Barstow, California 92311.

The project consists of Design / Build, engineering, fabricating, installing and any other additional elements to complete a turnkey installation of a new heavy duty in-ground vehicle lift.

The Engineer's estimate for this project is \$160,000

A mandatory job walk has been scheduled for Thursday, October 1, 2020, 10:00 am at 900 S Avenue H, Barstow, CA 92311.

Copies of the plans, specifications, and contract documents are available from the City of Barstow, 220 E. Mountain View Street, Suite A upon payment of a \$25.00 non-refundable fee if picked up, or payment of a \$35.00 non-refundable fee if mailed. In accordance with the provisions of California Public Contract Code § 3300, and Business and Professions Code § 7028.15(e), the City has determined that the contractor shall possess a valid <u>Class A and Class D-21</u> contractor's license at the time that the contract is awarded. Failure to possess the specified license shall render the bid as non-responsive and shall act as a bar to award of the contract to any bidder not possessing said license at the time of the award.

CONTRACTORS ARE REQUIRED BY LAW TO BE LICENSED AND REGULATED BY THE CONTRACTORS' STATE LICENSE BOARD. ANY QUESTIONS CONCERNING A CONTRACTOR MAY BE REFERRED TO THE REGISTRAR, CONTRACTORS' STATE LICENSE BOARD, P.O. BOX 2600 SACRAMENTO, CA 95826. At the time the contract is awarded, the contractor shall be properly licensed in accordance with the laws of this state. The first payment for work or material shall not be made unless and until the Registrar of Contractors verifies to the City that the records of the Contractors' State License Board indicate that the contractor was properly licensed at the time the contract was awarded. Any bidder or contractor not so licensed shall be subject to all legal penalties imposed by law including, but not limited to, any appropriate disciplinary action by the Contractors' State Board. Failure of the bidder to obtain proper and adequate licensing for an award of a contract shall constitute a failure to execute the contract and shall result in the forfeiture of the security of the bidder. (Public Contract Code § 20103.5)

CONTRACTORS AND SUBCONTRACTORS ARE ALSO REQUIRED TO BE REGISTERED WITH THE CALIFORNIA DEPARTMENT OF INDUSTRIAL RELATIONS FOR ANY BID PROPOSAL SUBMITTED ON OR AFTER MARCH 1, 2015, AND FOR ANY CONTRACT FOR PUBLIC WORK ENTERED INTO ON OR AFTER APRIL 1, 2015. A contractor or subcontractor shall not be qualified to bid on, be listed on a bid proposal for, or perform any public work contract unless it is currently registered with the California Department of Industrial Relations as described in Labor Code §1725.5.

Bids must be prepared on the approved bid forms in conformance with INSTRUCTION TO BIDDERS and submitted in the envelopes provided, sealed and plainly marked on the outside:

"SEALED BID FOR DESIGN/BUILD TURNKEY INSTALLATION OF FLEET SERVICES NEW HEAVY DUTY IN-GROUND VEHICLE LIFT PROJECT NO. 2020-04 DO NOT OPEN WITH REGULAR MAIL"

The bid must be accompanied by a bid guarantee in the amount of 10% of the total bid by 2:00 p.m. ON THE DATE ADVERTISED FOR THE OPENING OF BIDS. More specifically, pursuant to Public Contract Code §§ 20170 and 20171, all bids for the project shall be presented, under sealed cover and shall be accompanied by one of the following forms of bidder's security in the amount of ten percent (10%) of the bid: (a) cash; (b) a cashier's check made payable to the City of Barstow; (c) a certified check made payable to the City of Barstow; or (d) a bidder's bond executed by an admitted surety insurer, made payable to the City of Barstow. Such security shall be forfeited should the successful bidder to whom the contract is awarded fails to timely execute the contract and deliver the necessary bonds and insurance certificates as specified in the contract documents.

To the extent applicable, at any time during the term of the Agreement for the proposed project, the successful bidder may, at its own expense, substitute securities equivalent to the amount withheld as retention (or the retained percentage) in accordance with Public Contract Code § 22300.

Pursuant to California Civil Code § 9550, a payment bond is required to be submitted for all projects estimated in excess of \$25,000.00.

The City has determined that the proposed project is a public works subject to the provisions of Labor Code § 1720 thereby requiring the Contractor to pay the prevailing wage rates for all work performed under the Contract. Accordingly, the proposed project is subject to compliance monitoring and enforcement by the California Department of Industrial Relations.

The City reserves the right to reject any and all bids.



700 RESPONSIBILITIES OF THE CONTRACTOR

700-1 PROJECT SPECIFIC SPECIFICATION SECTIONS:

The work embraced herein shall be done in accordance with the Standard Specifications for Public Works Construction, "Green Book" (SSPWC), Current Edition, the 2019 California Building Code (CBC), the California Electric Code (CEC), and the California Fire Code CFC) insofar as the same may apply and in accordance with the following special provisions.

700-2 - PROSECUTION OF WORK

Following the approval of the contract, a Notice to Proceed will be issued. Contract time shall commence on the day the Contractor begins any work at the construction site, which shall be within

15 WORKING DAYS

Of the date the City of Barstow executes this contract. After such starting date, work shall be diligently prosecuted to completion within:

200 WORKING DAYS

Liquidated damages shall be \$500.00 per day.

Prior to commencing any work on the project site, Contractor shall obtain encroachment permit from the City of Barstow. The permit will be issued at no cost after the contractor's representative attends a pre-construction conference and all specified requirements are complied with.

700-3 EMERGENCY INFORMATION

The Contractor shall provide the following information in writing and submit it with the signed contract, contract bonds and certificates of insurance. Failure to comply may result in delays in the processing of the contract documents.

7.	Special Provisions page F-52; says the contractor shall begin work within 15 days of the date the City of Barstow executes this contract. And the work shall be completed within 30 working days. And there are liquidated damages of \$500.00 per day. We estimate our construction time from the first sawcut to concrete reaching full cure time to be 45 – 60 days. Additionally, at this time anticipated delivery of the new lift equipment from our supplier is a minimum of 150 days from time of order. I understand that production times at the factory have been affected due to the corona virus so it is possible delivery times may be affected additionally. It is impossible for us to meet the schedule as is now written and request this language be changed. Project Timeframe: If I understand it correctly, after receiving the Notice to Proceed, the contractor has 15 calendar days to begin the work and then 30 working days after that to complete the work. This timeframe only works if the City of Barstow agrees not to issue the Notice to Proceed until 1) plans and engineering are developed, 2) permits are approved by the City of Barstow, and 3) the heavy duty in ground lift has been ordered, manufactured, and shipped. That whole process is likely to take 180 days (plans and engineering – 30 days, plan review by the City - 30 days, + equipment lead time – 120 days). Based on legitimate reasons, the contract has provisions for requesting contract extensions and avoiding liquidated damages. d. The City is aware the Coronavirus pandemic may impact manufacturing of the new lift and will work with awarded contractor. e. Within the 15 days, A Notice to Proceed will be issued in order for the plans and the engineering to be developed and approved. The equipment shall be order within or around the 15 days. The City will work with the contractor in regards to the delivery of the equipment. It is anticipated turn-key completion of the vehicle lift should take approximately 60 working days after equipment delivery.
