GENERAL, NON-AGENDA PUBLIC COMMENT:

JOHN "TEX" WILLIAMS, BARSTOW, CALIFORNIA

Q: Can records of Planning Commission discussions regarding EC Barstow's parking be provided and are restrooms compliant?

A: The minutes from the Planning Commission are public information. The restrooms are not fully compliant to the best of the City's knowledge.

ITEM 5: MEASURE Q FUND FINANCIAL REPORT FISCAL YEAR 2021-2022 - 1ST QUARTER

MIKE HERNANDEZ, BARSTOW, CALIFORNIA

Q: Why is the 2nd Quarter Measure Q Fund Financial Report not available?

A: December sales tax collections by businesses are not due to the State of California until January 31. The City does not receive December sales tax collections for Measure Q from the State of California until the end of February. Thereafter, in March, a Measure Q meeting can be scheduled when the December Sales Tax collections information is available and can be reported out.

Q: Is there an established meeting schedule for the Measure Q Resident Oversight Commission (ROC)?

A: The ROC meets quarterly in March, June, September and December of each year. The ROC determines the subsequent meeting date at each meeting.

ITEM 6: PRESENTATION OF ANNUAL COMPREHENSIVE FINANCIAL REPORT (ACFR) FOR FISCAL YEAR ENDED JUNE 30, 2021

Q: Is ACFR included the interest earned from the Measure Q fund?

A: Yes, Measure Q funds are invested and earn interest income as part of the City's pooled investments. The interest earnings are reported out in the City's Annual Comprehensive Financial Report.

ITEM 12: RATIFICATION OF ACCOUNTS PAYABLE EXPENDITURES

- Q: What is the status of the Redevelopment Agency and how long the City was responsible for financial obligations?
- A: The Redevelopment Agency remains in operation to pay recognized obligations of the RDA until those obligations have been retired. There remains one bond payment on the RDA bond issue which will be paid in September, 2022. After any remaining obligations in the Property Management Plan have been met, the City can initiate the dissolution process with the San Bernardino Countywide Oversight Board.
