Q: How is the City's bio-solids contract with Synagro affected by the cease and desist order issued to Synagro on September 29, 2022?

A: Prior to executing the contract, staff reached out to several regulating organizations, and due to some of the responses, staff baked in the two other EPA-approved locations. Unfortunately, it comes at an increased cost per ton.
